Course Facilitator

Classes will be facilitated by Nova Environmental, Inc. Nova Environmental has been providing environmental testing, consultation and training services to a wide range of clients throughout the State of Michigan since 1988. By EPA regulation classes may not exceed 30 participants.

EPA required, by April 22, 2010, for all contractors who work in pre-1978 housing and child-occupied facilities, including: renovation contractors, maintenance workers in multi-family housing, painters and other specialty trades.

This day long seminar will provide a certificate to individuals who will be designated as "EPA Certified Lead Renovators."

The Certified Lead Renovator:

- must be present at each work site for Target Housing (a home or residence built on or before December 31, 1977)
- or -
- Child Occupied Facilities (any pre-1978 building or portion of a building regularly visited by children under 6 years such as; schools, child care centers, head start program facility/rooms, latchkey program facility/room, or hospitals rooms.)
- and -
- must be on-site at each impacted building on a daily basis.
- must be at the job-site during paint testing, sign posting, work area set-up and clean-up phases of the work.
- provide training to the non-Certified work staff that will be working on buildings affected by this regulation.

Note: Each contractor performing work that disturbs lead-based paint must have their own Certified Lead Renovator present - not just one per job site.
