UNDERGRADUATE SCHOLARSHIP PROGRAM 2009**

-- POSTMARK DEADLINE: APRIL 15, 2009 --

A. Eligibility

1. Applicant **MUST** be a college sophomore or junior. Junior-level applicants **MUST** have one full academic year of coursework remaining at the beginning of the fall 2009 term.
2. Applicant **MUST** desire a career in construction.
3. Applicant **MUST** pursue a BS-degree granting program in construction or civil engineering. A dual degree with construction and/or civil engineering as one part is acceptable. Student **MUST** be enrolled full-time; part-time students are not eligible for awards.
4. Applicant **MUST** be a U.S. Citizen or **documented** permanent resident of the United States. (i.e. must possess a "green card")

B. Requirements

1. **Applicant is responsible for insuring that all items listed below are submitted to the Committee and postmarked by April 15, 2009.**
 - a. completed three-page, **signed** application.
 - b. **one** evaluation form completed by a recent employer.
 - c. official **transcript** of college grades (see Item II.I of application).

NO reminder regarding submission of this information will be provided to applicant prior to the program deadline.

C. Awards

1. Scholarship amount will be pre-determined each year by the Fund Trustees. **Six \$2,000 scholarships will be awarded in 2009.**
2. Applications will be reviewed and winners selected by the Board of Trustees of the AGC of Michigan Educational Endowment Fund, which will consider applicant's interest in construction, grades, extracurricular activities, employment experience, evaluation, and financial status. The Trustees reserve the right to interview applicants.
3. Awards will be announced by May 15, 2009 and winners will be notified by mail in late May, 2009.
4. Checks will be sent directly to the university the student attends in August prior to the school year.
