



## AGC Michigan / MIOSHA Alliance 2017-2020

### Individual Contractor Agreement

The AGC Michigan / MIOSHA Alliance is an effort to improve Michigan construction safety and health through a visible promotion (the use of a job site banner), an open-door policy for periodic safety and health audits by the MIOSHA CET Division and promoting of the available safety and health training to employees at all participating job sites.

An AGC Michigan member contractor can embrace this Alliance Agreement on all their projects or single out an individual project that they are willing to agree to participate in Alliance's directives.

By becoming a part of this Alliance, either on an individual project basis or a company wide basis, a member construction company pledges their firm to achieving a high level of safety and health performance.

By becoming a part of this Alliance a member contractor agrees to:

1. Post a banner announcing their expanded safety efforts with the assistance of AGC Michigan and MIOSHA at all participating job sites. A photo of the banner will be provided to AGC of Michigan.
2. Offer an "open door" policy to the MIOSHA CET Division allowing job site safety and health audits at any time during the regular working hours. (CET audits do not issue citations for safety or health violations; however, CET audits do require corrections of any recognized serious unsafe situation.) A summary report will be provided to AGC of Michigan on a quarterly basis.
3. Provide a job site bulletin board listing their safety personnel and the safety personnel of the other job site contractors. Contact information will be provided to AGC of Michigan and updated on a quarterly basis.
4. Provide a "safety orientation" to workers on site. The number of safety orientations will be reported to AGC of Michigan on a quarterly basis.
5. Provide a summary report of special safety training conducted at the participating project on a quarterly basis.
6. Provide special on site safety training as conducted by AGC of Michigan.

By becoming part the Alliance, a member contractor agrees to provide to both the AGC Michigan and MIOSHA location addresses of all participating projects, starting date, completion date, contact names and phone numbers.

The following member contractor agrees to become part the AGC Michigan/ MIOSHA Alliance and will comply with all directives of the alliance.
